## **Preamble**:

Details of college, affiliation, approval

#### 1. Introduction

This Prospectus contains rules and regulations applicable for selection and admission to the B.Sc. Nursing Course, against sanctioned intake for the academic year 2024-25, in the college, including 15% NRI seats set apart for the dependents of Non Resident Indians.

This prospectus is subject to modification/addition/deletions may be deemed necessary by the college and subject to the Judgments of Honorable Courts of law

#### 2. Number of seats

The College is conducting B.Sc. Nursing course with an intake of 50 seats. Out of the above, 7 seats shall be filled up by NRI quota, 18 seats shall be filled up by Management Quota and balance 25 shall be filled by Government quota/LBS.

In the event of non availability of eligible candidates in the NRI quota, such seats will be filled up by the candidates in the Christian minority category. If sufficient candidates are not available in the Christian minority category, such seats will be filled up by the candidates from General merit.

The number of seats, allocation of seats under various quotas may also change subject to conditions to any consensual agreement that may be signed between Government of Kerala and the college.

## 3. Eligibility for Admission

#### Academic

- (i) Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the Universities in the State of Kerala with Aggregate of 50% marks in Physics, Chemistry, Biology and 50% marks in English in second Year only are eligible for admission.
- (a) Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned. There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.
- (ii) Eligibility Certificates: Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

- (b) Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned. There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.
- (iii) Eligibility Certificates: Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

#### Age

- (i) Applicants should have completed17 years of age on the 31<sup>st</sup>December2023. No relaxation of the minimum age will be allowed.
- (ii) Self attested copy of relevant page of school record namely SSLC/ICSE/CBSE/certificate showing the date of birth / copy of birth certificate should be produced at the time of admission

## 4. How to Apply.

Application for admission to course B.Sc. Nursing course can be registered only online through a single application. The provision for applying online is available at the website www.mountzionnursingcollege.com.Prospectus can also be downloaded from www.mountzionnursingcollege.com .However,it will not be available by post Submission of more than one application by a candidate will lead to rejection of the candidature.

#### Application Fee:

- (i) The application fee will be Rs.800/- for all candidates, payable through online by using Credit/Debit/Internet Banking facility. Application submission will be completed only after successful payment of Application fee through online.
- (ii) If the payment is debited and you are not guided to the second stage please inform us to **mountzionnursingcollege@gmail.com** with your login details or email-id or mobile number, we will provide you the required help within 24 Hrs.
- (iii) Application fee on ceremitted will not be refunded in any circumstances.

Remittance of Application Fee and Submission of Application Form:

The candidates can get the instruction to make the payment and submission of application form in the link "Admission" on the website www.mountzionnursingcollege.com. No need of submission of hardcopy of application.

## 5. Preparation of Merit List

Out of 50 seats 25 seats will be filled by managements from among the online

Merit list:

- (a) Applications on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria by following the reservation criteria as mention in clause 2.1 and 2.2 of this prospectus.
- (b) Out of 25 seats 7 NRI seats shall be filled up from qualified students as per G.O (MS)No.243/2014/HRFWDdated6.08.2014ofGovt.ofKerala. The following original documents shall be submitted at the time of admission.
  - 1. Sponsorship Certificate
  - 2. Attested copy of the passport of the sponsor
  - 3. The attested copy of the relevant page of the passport twhere Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian Embassy or consulate.
  - 4. \*Relationship Certificate from the Village Officer/Tahasildar

\*Relationship with the sponsor should comply the Government order No.GO (MS)No.193/2013/H&FWDdtd.22.05.201&KUHSOrderNo.2836/ACB/kuhs/2014, dated12.06.2014

Resolution of tie while ranking: In the case of atiein the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.

Validity of the meritlist: The published meritlist will be valid till 30-09-2022 or the date upto which the meritlist shall be kept alive in terms of instruction/direction of competent authority. Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.

Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

## 6. Selection by Allotment Process

The Allotment Processfor Seats in Mount Zion Nursing College for which will be made as per the schedule included in the prospectus and allotments will be strictly based on the merit by following the reservation criteria as mention in clause 2.1 and 2.2 of this prospectus.

Christian minority Quota: The selection of candidates to Christian minority community will be based on the merit list prepared by the college. All right of claim for eligibility relaxation or community claim shall be sustained with the required documents at the time of admission. If sufficient candidates are not available in the list of applicants, the vacant seats will be

Filled up from the eligible candidates as mentioned in clause No.3.1 and 3.2

## 7. Admission & Payment of Fees

The selected candidates will be informed through SMS into the registered mobile number provided in the application

The students shall pay all fees of the 1<sup>St</sup>year of the course at the time of admission which will not be refunded at any circumstances.

Fees tipulated by the Fee Regulatory Committee/Govt.ofKerala for 85% of seats is as follows:

Tuitionfee-Rs.73, 025/-

Specialfee–Rs. 23,300/-

Cautiondeposit- Rs.10, 000/-(Refundable)

The entire candidate should pay other fees due to statutory bodies (KUHS,

KNMC&INC) as and when notified later by the College

Tuition fee for NRI candidates is Rs.95000/-per annum

(Note: Special fee for B.Sc Nursing Courses from 2<sup>nd</sup> year onwards shall be Rs 19,300/- uniform fee a maximum of Rs 5,500/- text books and records a maximum of Rs 5.500/- & the rent and mess charge a maximum of Rs 72,000/- per annum may collected.

Selected Candidates should report for admission on the date as instructed in the SMS along with the following documents

- Aadhar card or any other identity proof as provided in the application.
- Mark list of the candidate at the qualifying examination.
- Pass Certificate of the candidate at the qualifying examination.
- Document (School Record, SSLC or equivalent) of the candidate to prove his/ her date ofbirth.
- Eligibility/equivalency certificate obtained from the Kerala University of Health Sciences by candidates who have passed the qualifying examination from authorities other than the State of Kerala/ CBSE/ ISCE.
- A Physical Fitness Certificate in the prescribed form at obtained from a Medical Officer in Government Service not below the rank of Assistant Medical Officer.
- Course and conduct certificate from the institution last attended.
- Transfer certificate (TC) from the institution last attended.
- Document/certificate required in proof of any benefit claimed in the application for reservation.

The candidates selected for NRI quota have to submit the following documents also along with the above documents

- 1. Sponsorship Certificate
- 2. Attested copy of the passport of the sponsor
- 3. The attested copy of the relevant page of the passport where Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian Embassy or consulate.

Selected candidates have to remit all the fees as mentioned above at the time of admission itself. The fee can be paid by RTGS/NEFT/DD/Netbanking/Onlinebanking. If all the fee as mentioned above is not remitted within the time of admission, the application of the Candidate will be removed from the admission process

If any candidate discontinues the course, after closing of admission as notified by the authority, the candidate has to pay the full fee of the remaining course (4yrs). The Collection of liquidated damages shall be as per the final decision of the AFRCor Court of Law.

## 8. Special Instructions

- (1) Ragging: Ragging in any form is strictly prohibited in all member colleges. All the member colleges are committed to abolish ragging in their campuses. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard.
- (ii) Every students is required to adhere strictly to the code of conduct of the institution to which he/she is admitted.
- (111) Any other items not specifically covered in this prospectus will be decided by the Controller of admission.
